TENDER TERMS & CONDITION

Sealed tenders are invited along with sample of 1 kg. (in duplicate) free of cost for the supply of carded wool as per details mentioned overleaf. Tenders should be enclosed in a properly sealed envelope addressed to the Dy Chief executive officer (Blanket), U.P. Khadi & Village Industries Board, 8-Tilak Marg, Lucknow invariably giving on the envelope names of the articles. The tenders mentioned in the tender notice are and shall be deemed to be only approximate and will not in any manner whatsoever be binding on this board.

All tenders are to be submitted upto 5 p.m. on 1-1-2018 in the office of the undersigned at Lucknow and shall be opened on the 02-01-2018 at 3 p.m. in the presence of those tenderers who choose to be present in the office of this Board at 8-Tilak Marg, Lucknow.

The tender will remain open for acceptance for a period of four weeks from the date of opening unless otherwise specified.

All tenders must be submitted in the prescribed form enclosed along with a Bank guarantee or F.D.R. for an amount Rs. 10,000.00 (Rs. Ten thousand only) tendered in favour of the U.P. Khadi & Village Industries Board, Lucknow on account of Earnest Money. Technical bid and financial bid will be separate.

All the columns of the tender form shall be duly properly and exhaustively filled in rates unit shall not be altered. Tender shall always be both in figures and words. The signature on the tenders shall be deemed to be authorised signatures. The tenders shall further be subject to the following special condition.

The Chief Executive Officer of the Board will have the right of rejecting all or any of the tender without giving any reason for the same.

SPECIAL CONDITIONS

1. Tenderers may tender separately for each of the items which form separate serial number in the tender notice but be allowed to break any such items or tenderer only a part of such items.
2. All tenderers must be for F.O.R. RAILWAY STATION nearest to our blanket factories, quotations ex-works or godown rate are liable to be rejected.
3. Preference will be given to those offers which stipulate firm prices and tenderer must have one year's experience for the wool supply.
4. It should be specifically stated whether the rates offered are inclusive or exclusive of G.S.T. In the absence of any such clear stipulation to this effect prices quoted will be supposed to be inclusive of G.S.T. In cases where the G.S.T. leviable legally on the date of tender should be clearly indicated.
5. The delivery period should specifically be stated. Earlier delivery may be preferred.
6. Tenderers are requested to give detailed description any specification of the articles quoted.
7. Tendering Firms are advised to see that the samples are delivered in the office of the U.P. Khadi and Village Industries Board, Lko. Secured sealed labelled and packed

properly. In case of tendering firms who send their samples through railway, it should invariably be sent through delivery service freight paid and railway receipt should be in favour of the Chief Executive Officer, U.P. Khadi & Village Industries Board, Lucknow. This office does not take the responsibility of taking delivery. Either from the railway or any other Road transport organization. Samples will not be returned unless otherwise specified. Tender without samples if specifically may not be considered unlocked and unsealed sample will not be accepted.

8. According to standard term, full payment will be made after the receipt check and verification of material at factory site. However in special cases, the Department may also be prepared to consider to allow 50% payment on receipt of R/R not through Bank after receipt of material and balanced 50% last one month after test and verification at site. The tender in which supplier through Bank are offered will not be accepted.
9. Successful tenderers will have to deposit security which would be 5% of cost of the goods to be supplied by the date specified in the acceptance letter. The earnest money received with the tender shall be adjusted towards the security in case of successful tenders who will have also to execute the agreement deed for successful execution of the contract. The security shall be refunded on satisfactory completion of the suppliers within the stipulated period. In the case of unsuccessful tenderers, the earnest money shall be refunded.
10. If any firm is found contracting the indenting officer either before opening or finalisation of the tender, its tender will be liable for rejection.
11. Special attention of the tendering firm is invited about the receipt of tender in time. Tenders received after the stipulated period due to any reason whatsoever, will not be entertained. Tenders are requested to see that their tenders are delivered in the office before the prescribed date and time after which no tender received either by post or by hand will be considered. Telegraphic tender giving all the relevant details of the carded wool offered must also be received before the due date and time.
12. In the event of any dispute, any officer of UPKVIB nominated by the Chief Executive Officer UPKVIB, Lucknow shall be the sole arbitrator and his decision shall be final and binding on both parties. All disputes are subject to Lucknow Jurisdiction.
13. The U.P. Khadi & Village Industries Board reserves the right of rejecting all or some of the quotations if so spilt up the contract without assigning any reason and in supersession of any of the conditions given here under:--

REMARKS.

1. The quantity mentioned below are approximate and subject to variation of 25% either way.
2. Tenders should give the fine carded wool otherwise their tender will not be considered.
3. The rates should be F.O.R. delivery free at Gopiganj (Bhadohi) Railway station Gyanpur Road (NER).
4. Lab & verification test will be taken by the Board before final payment.

5. The representative of the Board may inspect stock before dispatch.
6. Tendering firms may note that it is essential to remit the requisite amount of Earnest money along with the tender failing which their offer shall not be considered.
7. Tender without sample or inadequate sample shall not be considered.
8. Sample received after due date and time of the tender notice will not be considered.
9. Time required for delivery should clearly be given in the tenders tendering firm will have to start supplies just after the receipt of supply order. Early delivery may be preferred.
10. The tendering firms should mention in the quotation their state and G.S.T. registration number as well as the firm registration number and in case of partnership names of partners and the name of the person with full address who is authorised to sign the tender execute the Agreement deed and name correspondence on behalf of the firm. In absence of the information the tender shall be rejected outright.
11. The tendering firms are also advised to produce sales Tax/G.S.T clearance certificate On form No..... before final payment.
12. In case the carded wool loss is found less than wool the entire lot is liable to be rejected.
13. If the technical bid is properly correct only then after financial bid will be open.
14. If the wool is found wet it will be at the option of the indenting officer either to accept it or reject it, If accepted it will be weighed only after drying rejected supplies (on any ground) will have to be removed by the supplier at their cost.
15. The goods must be dispatched to the centre, Gopiganj (Bhadohi) within thirty Days from the date of receipt of this order.
16. Each kind of wool must be dispatched to the authorized centre in the consignment to avoid repetition of Yield quality, micron, and M.F.L. testing etc.
17. A committee framed by order no. 187-91 dated. 29.8.2017 of Chief Executive officer UPKVIB will be checked the yield of carded wool at the production centre and after approval of above committee as per deducted yield the proceeding of payment will be done by incharge officer of the blanket production centre Gopiganj (Bhadohi).
18. In the event of the tender being accepted the tenderer shall have to execute an Agreement in the form accompanying the tender notice and the condition of the Said agreement shall be deemed to have always been part of the tender.
19. The terms and condition of the agreement shall be binding upon the Tenderers notwithstanding the fact that the agreement form may not have been Signed by him even though so required to do.
